1. Students Appearing in Person

- Other state-issued ID
- Valid U.S. passport

The University will maintain a copy of your photo ID that is annotated with the date it was received and the name of the Student Financial Aid Office Official authorized to collect your ID.

2. Students Unable to Appear in Person
